### B. Maximum Splash Fees

#### Non-time standards meets

Maximum Individual Splash fee for NTS	\$ 3
Maximum relay fee for NTS	6

#### Meets with Time Standards

Maximum Individual Splash fee – time standards	\$ 5
Maximum relay fee for meets with time standards	10

#### Preliminary Finals meets

Maximum Individual Splash for prelim/ finals	\$ 6
Maximum relay fee for prelim/finals	12

#### Regional and Fall League Championships

Individual Splash fee – Regional & Fall League	\$ 4.50
Relay Splash fee – Regional & Fall League	\$ 8

#### 8 and Under Championship

Individual Splash fee	\$ 4
Relay Splash fee	\$ 8

#### Time Trials

Twice the maximum event splash fee as specified above.<sup>7</sup>

**Note:** The LSC will no longer grant additional pool rental surcharges or any other surcharges for facility costs in running a meet, including state championships.

### C. Administrative Fees

Fee for returned check or electronic transfer	\$ 30 each
Fee for submission of athletes registration on paper form	\$ 5 each
Fee for athlete registration between meet entry dead line and start of meet. “Emergency Registration” <sup>5,6</sup>	50% <sup>6</sup>
Fee for unregistered athlete participating in competition	\$100 each
Fee for assistance with / training regarding registration, membership, Hy-Tek matters or other assistance	\$ 50 / hour

<sup>5</sup> Fees are in addition to regular USA/Az registration fees and such registrations are subject to then current USA/AZ rules and regulations and availability of AzSI personnel to affect such emergency registrations. This is not a guarantee. Emergency Registration fee will be refunded if registration can not be completed in the time frame requested.

<sup>6</sup> Fee is 50% of the then current athlete registration, based on class of registration, in addition to regular membership fee as required in footnote 5 above.

<sup>7</sup> One half (1/2) of the Time Trial Fees are paid to the LSC with the meet report.
