Footnotes:

- Does not include fees for camps, swimposiums or other special events.
- Emergency Athlete Registrations additional charge of ½ current registration fee for seasonal or year round memberships
- Revisions to sanctioned / approved meets for scrivener errors will be made without charge. All other changes require new sanction number together with corresponding additional sanction / approval revision fee.
- Fees are in addition to regular USA/Az registration fees and such registrations are subject to then current USA/AZ rules and regulations and availability of AzSI personnel to affect such emergency registrations. This is not a guarantee. Emergency Registration fee will be refunded if registration cannot be completed in the time frame requested.
- Fee is 50% of the then current athlete registration, based on class of registration, in addition to regular membership fee as required in footnote 4 above.
- One half (½) of the Time Trial Fees are paid to the LSC with the meet report.

¹⁰ Rentals booked with in three days of the start of competition will be charged a 50% premium of all charges.

¹¹ Rental to nonmember should consult AzSI Policy 240 for details and costs associated with rental to nonmembers. The minimum charge, if permitted, will be 200% of the current member rates and may be significantly higher.

¹² Maximum Splash Fees effective through March 30, 2016 splash fees for Championship series meets increases are effective immediately and are changed to reflect new fees.

¹³ Maximum Splash Fees in LSC members effective April 1, 2016 – Maximum Splash Fees Out of LSC members effective September 1, 2018 may be up to 2 times the fees charged for AZSI registered athletes.

¹⁴ Such fees are payable to Arizona Swimming.

¹⁵ For clubs whose total athlete registration exceeds 100 during the immediately prior registration year a \$10 paper filing processing fee will be assessed for each registration.
