SWIMMING	Subject: CLUB INCENTIVE	REVISED DATE: 3-15-2023

A. Purpose:

- a. AZSI has established a Club Incentive Program to provide annual monetary incentives for clubs and volunteer participation in LSC activities, committees, etc.
 - i. Eligible clubs are classified as small or large club based upon athlete membership of a club as of the last day of the previous membership registration year ("Registration Period), August 31. For purpose of this policy, there are two classes of membership:
 - 1. Small club is defined as those with 150 or fewer athletes as of the end of the Registration Period.
 - 2. Large club is defined as those with 151 or greater athletes as of the end of the Registration Period.
 - ii. Award Period for these Club Incentives, starts on September 1 of each year and ends on August 31 of each year.
 - iii. Awards under this policy are determined based on point system the clubs with the club with the greatest number of points winning.

B. Procedure:

- a. In order to be considered for an award under this policy, clubs must be a current Safe Sport Recognized Club Program, The Safe Sport Recognized Club must submit to the office the Club Incentive Tally sheet providing their achievements under the policy and the points allocated to them as a result.
 - i. Clubs must submit their qualifying information no later than October 1 of each year.
 - ii. All items submitted as part of the qualifying process are subject to verification.
- b. Using the Club Incentive Tally sheet provide names of each of the participants in each category
 - i. Participants may be athletes or non-athletes.
 - ii. Participation must be able to be verified by meeting minutes, workshop sign in sheets, or other records held provided to the LSC office during the award period.
 - iii. On the Club Incentive Tally sheet "active" refers to verifiable participation.
 - iv. A club must have earned a minimum of 20 points to be considered for any level of award.

C. Awards,:

a. Monetary awards under this policy shall be based on total points awarded during the Award Period. The Operations Director shall verify items submitted as part of this program and shall notify the General Chair of the award winners prior to distribution of the Awards, paid by check to the clubs.

- b. Such awards levels shall be in the amount of:
 - i. First place \$750
 - ii. Second place \$500
 - iii. Third place \$250
- c. Should there be a tie for any award levels the teams with the same score shall split the sum of the two levels equally.
- d. Protests regarding the award shall be forwarded to the Board of Directors within ten calendar days following the original awards. The decision of the Board of Directors shall be final
